THE NEW PSA "DOES YOUR HOTEL KNOW?" WAS LAUNCHED ON JULY 1 WITH THE SUPPORT OF 11 COMPANIES. IT HAD OVER 270,000 VIEWS BY THE END OF THE YEAR. IT LINKED TO A CAMPAIGN AIMED AT BOTH THE HOTEL INDUSTRY AND THE PUBLIC TO SPREAD THE WORD ABOUT CHILD SEXUAL EXPLOITATION, TO LEARN HOW TO IDENTIFY IT AND HOW TO REPORT IT. CNN USED THE VIDEO IN A PIECE THEY RAN ABOUT OUR WORK WITH THE TRAVEL INDUSTRY.

WE SPOKE AT VENUES THROUGHOUT THE UNITED STATES. NINE HUNDRED AND THIRTY NINE PEOPLE ATTENDED EVENTS THAT WERE SPONSORED BY ECPAT-USA. OVER NINE THOUSAND PEOPLE ATTENDED OTHER EVENTS AT WHICH WE SPOKE THAT WERE SPONSORED BY OTHERS.

WE CREATED A CAMPAIGN CALLED ECPAT UNITED WITH A PACKAGE OF INFORMATION TAILORED TO THE EDUCATIONAL NEEDS OF CHURCHES AND RELIGIOUS ORGANIZATIONS. IT RESULTED IN A NEW DOCUMENT, A FAITH-BASED
